## TRAVEL FEES

For off-site locations, an additional fee (see below table) will be added to the final total. If travel fees apply, the deposit may be used towards the travel fee.

# BILLING:

All contracted services, including gratuity, will be **billed to the card on file, day of services**. Any additional services will also be billed to the card on file. It is the responsibility of the person on the contract to collect fees from the wedding party.

It is **IMPORTANT** to start on time, to allow stylists the ability to complete services. Additional fees may apply for a late start time and finish time.

## ADDITIONAL FEES

- Services provided outside of regular salon hours: \$100
- Sunday, Monday, or Holiday services of \$300 per stylist in salon and \$400 per stylist when travel services are requested.

## DEPOSIT

A deposit of \$200 is required to reserve a wedding date. This is **non-refundable**. The \$200.00 payment can be paid by credit card, cash, or check. Due to the nature of the business, your wedding date will not be held until a deposit is paid and a contract is received. Your deposit will be deducted from the wedding day balance, which will be due on your wedding day.

## SERVICE/PARTY CHANGES + CANCELLATION POLICY

Any changes to the requested services or number of people in the party must be submitted 60 days before the wedding day. After that date, you will be responsible for the cost of all services listed in contract.

Cancellations can be made up to 60 days before the wedding day without any charges. If you cancel less than 60 days prior to your wedding day 50% of the total wedding date rate quote will be charged to the credit card provided. If you cancel 30 days or less of the wedding day you will then be charged 100% of the total wedding day rate quoted. We reserve the right to add 20% gratuity to all services.
